- Deviations are available to the general public. To request a deviation please call 541-575-2370. Same day requests will be accommodated when operationally feasible.
- Every effort will be made to keep to the schedule. Weather and road conditions could disrupt our schedule. Please plan your trip accordingly.
- A \$5.00 fee will be charged if home pick up is required.
- Passengers from Prairie City should call 24 hours in advance to ensure pick up.
- Passengers arriving or departing the Redmond Airport should call 24 hours in advance to notify us for a pickup at the terminal.
- No open alcoholic beverages or illegal drugs are allowed on the bus.
- No smoking, vaping or e-cigarettes
- Its recommended passengers wear safety belts and remain seated until the bus comes to a complete stop.
- We do no haul freight.
